Identify criteria which support the candidate's qualifications for this award. These materials should clearly describe and, when appropriate, document the nominee's qualifications for the award. A **maximum** of 10 pages may be submitted, which include responses to the five categories below and letters of support. All submissions must be on standard 8.5" x 11" page or letterhead.

### **NOMINATION CRITERIA CATEGORIES**

Category	Weight
Contributions to business education through teaching Include information about classroom teaching performance, classroom management, years of experience, and subject areas taught; and give evidence of effectiveness. Supporting documentation from students, administrators, and/or professional colleagues is essential to these criteria.	60 points
Participation and offices held in local, state, regional, and national professional associations  Also include special activities that resulted in needed changes or improvements in the profession. Describe the impact of such activities.	10 points
Contributions to business education through major articles, publications, and research activities  Describe the significance of such activities of the profession. List – do not include copies of – articles, monographs, books, etc., published by the nominee.	10 points
Contributions to business education through religious, civic, government, cultural and private business organizations	10 points
Involvement in other activities such as administrative responsibilities and working with student organizations	10 points
